RISK ASSESSMENT PANEL

The morning segment of this year's Procurement Day will focus on one of the key issues identified as needing to be addressed during the very first Procurement Day: *Risk Assessment and Analysis.*

A common thread of discussion in 2011. and carrying forward in successive years, has been the that each party should responsible for their piece of the project. General consensus was that there are inherent risks that should be allocated and 'owned' by each specific party within a design & construction project. Risk can be broken down into responsibilities and identification of those risk/responsibilities is critical to the success of a project. It is often a difficult process to distill those risks down and identified who is the party that is best able to manage the risk or should manage the risk. It is not necessarily appropriate to transfer risk down the project chain.

Topics for discussion amongst the panel members and delegates will include:

- · Whose Risk/Liability is it?
- Identifying Roles and Responsibilities
- Who is best suited to management the Risk?
- Examples of Risk Transfer and analysis – Appropriate or Not Appropriate?
- Impact of the Risk
- Ways in which risk/liability is transferred
- Understanding levels of liability insurance

PREQUALIFICATION PANEL

The purpose of prequalification is to ensure that the proponents invited to bid or design the work are capable of delivering quality and value specific to the project requirements.

Prequalification is frequently used for public projects, where the opportunity to be considered as the proponent must be open to all, while at the same time allowing the owner to manage the risks associated with the open tender process.

The owner, through pre-determined criteria, eliminates candidates who do not demonstrate that they have the necessary financial capacity, technical expertise, managerial ability, project success, and relevant experience for the project at hand.

Prequalification also has the potential to simplify the award of the contract process; therefore the prequalification process should be completed prior to the issuance of the tender documents.

The panel of experts will discuss best practices for the prequalification process from a cross section of view points including Owners, Contractors, Architects, Lawyers and Insurance Industry representatives.
